No more than six (6) Disney 3-Day/4-Day Military Promotional Tickets may be purchased by any Eligible Service Member or spouse (regardless of the place of purchase and whether purchased by that person or that person's spouse). In addition, one of the six (6) Tickets purchased must be used by the Eligible Service Member or his/her spouse.

"Eligible Service Members" are active or retired members of the U.S. military, including the National Guard, Reservists, the U.S. Coast Guard, the Commissioned Corps of the Public Health Service (PHS) and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA). ONLY!

During the offer period, "Eligible Service Members" (or their spouse, but not both) may purchase **Disney's Military Promotional Tickets (3-Day or 4-Day Park Hopper)**. Tickets are limited to (6) per "Eligible Service Members".

During the period from November 5, 2019 to December 15, 2020 (the "Offer Period"), Disney 3-Day/4-Day Military Promotional Tickets may be purchased at participating U.S. military sales outlets ONLY by Eligible Service Members (defined below) or their spouses (but not both), for use by themselves and other family members and friends, in accordance with these "Special Provisions." These Tickets may not be otherwise transferred, distributed or resold.
3. "Eligible Service Members" are active or retired members of the U.S. military, including the National Guard, Reservists, the U.S. Coast Guard, the Commissioned Corps of the Public Health Service (PHS) and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA).
4. Participating military sales outlets must require that Eligible Service Members (or their spouses) present valid military identification to purchase Disney 3-Day/4-Day Military Promotional Tickets.
5. Disney 3-Day/4-Day Military Promotional Tickets entitle a Guest to admittance to both Disneyland® Resort Theme Parks for three (3) days or four (4) days, including visits to both Theme Parks on the same day.
